

RESOLUTION NO. 2019-R-141

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AUTHORIZING ASSIGNMENT OF THE SETTLEMENT AGREEMENT BETWEEN THE CITY OF NORTH MIAMI AND MEDIANET OF SOUTH FLORIDA, INC., PREVIOUSLY ASSIGNED TO IDON MEDIA, LLC, TO NOW BE ASSIGNED TO OUTFRONT MEDIA, LLC; PROVIDING AN EFFECTIVE DATE AND FOR ALL OTHER PURPOSES.**

**WHEREAS**, MediaNet of South Florida, Inc. (“MediaNet”) is a sign company that previously filed three lawsuits against the City challenging the constitutionality of the City’s former sign ordinances; and

**WHEREAS**, The City and MediaNet resolved the three law suits by entering into a Settlement Agreement (the “Settlement Agreement”) dated February 16, 2006; and

**WHEREAS**, Section 11 of the Settlement Agreement gives MediaNet the full right to assign the Settlement Agreement and that any successor in interest shall become completely responsible for the fulfillment of all of MediaNet’s rights and responsibilities pursuant to the Settlement Agreement; and

**WHEREAS**, Section 11 of the Settlement Agreement makes assignment of the Settlement Agreement subject to the approval of the City Council; and

**WHEREAS**, Section 11 of the Settlement Agreement also requires that the City Council must grant or withhold its approval of assignment within 30 days of the receipt of a request in writing for the approval of assignment; and

**WHEREAS**, the Settlement Agreement was previously assigned from MediaNet to Idon Media, LLC in 2017; and

**WHEREAS**, by letter dated November 7, 2019, Idon Media, LLC, MediaNet’s successor in interest, has requested that the City of North Miami approve the assignment of the Settlement Agreement to OUTFRONT MEDIA, LLC.

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA AS FOLLOWS:**

**Section 1. Authority to Assign Settlement Agreement.** The City Council grants its approval of the assignment of Settlement Agreement between Idon Media, LLC and OUTFRONT MEDIA, LLC.

**Section 2. Effective Date.** This resolution shall become effective immediately upon adoption.
