

RESOLUTION NO. 2019-R-146

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, APPROVING THE MUTUAL AID AGREEMENT AND JOINT DECLARATION BETWEEN THE CITY OF NORTH MIAMI POLICE DEPARTMENT AND THE CITY OF SUNNY ISLES BEACH POLICE DEPARTMENT; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.**

**WHEREAS**, it is the responsibility of the governments of the City of North Miami, Florida, and the City of Sunny Isles Beach, Florida, to ensure the public safety of their citizens by providing adequate levels of police services to address any foreseeable routine or emergency situation; and

**WHEREAS**, the agencies are desirous of entering into an MAA because of the existing and continuing possibility of the occurrence of law enforcement problems and other natural and manmade conditions which are, or are likely to be, beyond the control of the services, personnel, equipment or facilities of the participating municipal police departments; and

**WHEREAS**, the MAA ensures the preparation of these law enforcement agencies will be adequate to address any and all of these conditions, to protect the public peace and safety, and to preserve the lives and property of the people of the participating Miami-Dade County municipalities; and

**WHEREAS**, the participating Miami-Dade County municipalities have the authority under Chapter 23, Florida Statutes, Florida Mutual Aid Act, to enter into a Mutual Aid Agreement.

**NOW, THEREFORE**, The City of North Miami, a Florida municipal corporation, and the City of Sunny Isles Beach in consideration for mutual promises to render valuable aid in time of necessity, do hereby agree to fully and faithfully abide by and be bound by the terms and conditions set forth in the MAA attached as Exhibit "A."

**NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:**

**Section 1. Approval and Authority to Execute.** The City Council hereby approves the Mutual Aid Agreement and Joint Declaration between the City of North Miami Police Department and The City of Sunny Isles Beach Police Department, and hereby authorizes the City Manager to execute this Mutual Aid Agreement and Joint Declaration.

**Section 2. Effective Date.** This Resolution shall be affective upon adoption.
