

RESOLUTION NO. 2019-R-149

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, RATIFYING THE SUBMISSION OF AN APPLICATION AND AUTHORIZING THE CITY MANAGER AND CITY ATTORNEY TO NEGOTIATE AND EXECUTE AN AGREEMENT BETWEEN THE CITY OF NORTH MIAMI AND THE FLORIDA DEPARTMENT OF TRANSPORTATION TO SECURE A KEEP AMERICA BEAUTIFUL GRANT IN SUPPORT OF COMMUNITY BEAUTIFICATION EFFORTS; PROVIDING FOR AN EFFECTIVE DATE, AND FOR ALL OTHER PURPOSES.**

**WHEREAS**, the Mayor and City Council are desirous of applying for and securing a grant from the Florida Department of Transportation (FDOT) Keep America Beautiful Affiliates Grant Program; and

**WHEREAS**, the City will request funds in the amount of Sixteen Thousand Dollars (\$16,000.00) with no required match in support of Keep North Miami Beautiful; and

**WHEREAS**, funds will be utilized to provide substantial opportunities to involve North Miami constituency in improving the community; and

**WHEREAS**, the City will focus its efforts on litter prevention, community beautification, sustainability and recycling; and

**WHEREAS**, the Mayor and City Council wish to authorize the submittal of a grant application as well as to fully authorize the negotiation and execution of an agreement for grant funds between the City and FDOT.

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AS FOLLOWS:**

**Section 1. Approval of Submittal of Application.** The Mayor and City Council hereby approve the submittal of the City of North Miami's application for a Grant from the Florida Department of Transportation (FDOT) Keep America Beautiful Grant Program.

**Section 2. Authority to City Manager and City Attorney.** The City Manager and City Attorney are hereby authorized to negotiate and execute an agreement between the City of North Miami, Florida and the Florida Department of Transportation, to obtain grant funds.

**Section 3. Effective Date.** This Resolution shall become effective immediately upon adoption.
