

RESOLUTION NO. 2019-R-151

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, APPROVING THE CITY ADMINISTRATION'S COMPETITIVE SELECTION OF H&R PAVING, INC. AND METRO EXPRESS, INC., AS THE TWO HIGHEST RANKED CONTRACTORS TO PROVIDE ASPHALT RESURFACING SERVICES, IN ACCORDANCE WITH THE TERMS, CONDITIONS AND SPECIFICATIONS CONTAINED IN INVITATION FOR BIDS NO. 04-19-20; FURTHER AUTHORIZING THE CITY MANAGER AND CITY ATTORNEY TO NEGOTIATE AND EXECUTE AGREEMENTS WITH SELECTED CONTRACTORS FOR THE PROVISION OF SERVICES FOR A COMBINED ANNUAL AMOUNT NOT TO EXCEED FOUR HUNDRED FORTY THOUSAND DOLLARS (\$440,000.00); PROVIDING FOR AN EFFECTIVE DATE AND FOR ALL OTHER PURPOSES.

WHEREAS, on October 30, 2019, the City of North Miami ("City") advertised *Invitation for Bids No. 04-19-20 – Asphalt Pavement Replacement Term Contract* ("RFP"), requesting bids from qualified and experienced Contractor(s) to provide all the necessary expertise, labor and materials for asphalt resurfacing work at various locations throughout the City (collectively referred to herein as "Services"), in accordance with the terms, conditions, and specifications contained in the IFB; and

WHEREAS, a total of four (4) contractors submitted bids in response to the IFB, from which H&R Paving, Inc. and Metro Express, Inc. (collectively referred herein as "Contractors") were found to be the top two (2) ranked contractors demonstrating to be the most advantageous to the City in the provision of Services; and

WHEREAS, Contractors have manifested the capability and willingness of providing Services to the City, for a combined annual amount not to exceed Four Hundred Forty Thousand Dollars (\$440,000.00), with an initial term of contract for three (3) years, with two (2) additional options to renew, on a year-by-year basis; and

WHEREAS, City administration respectfully requests that the Mayor and City Council approve the selection of Contractors and further authorize the City Manager and City Attorney to negotiate and execute agreements with selected contractors; and

WHEREAS, the Mayor and City Council find the selection of Contractors to be in the best interest of the City and that the provision of Services are designed to protect the health, safety, and welfare of the community.

NOW THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. Approving Selection of Contractors. The Mayor and City Council of the City of North Miami, Florida, hereby approve the City Administration's competitive selection of H&R Paving, Inc. and Metro Express, Inc., as the two highest ranked contractors to provide asphalt resurfacing services, in accordance with the terms, conditions, and specifications contained in the *Invitation for Bids No. 04-19-20*.

Section 2. Authority of City Manager and City Attorney. The Mayor and City Council of the City of North Miami, Florida, hereby authorize the City Manager and City Attorney to negotiate and execute agreements with selected contractors for the provision of services, for a combined annual amount not to exceed Four Hundred Forty Thousand Dollars (\$440,000.00).

Section 3. Effective Date. This Resolution shall become effective immediately upon adoption.
