

RESOLUTION NO. R-2009-6

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, DESIGNATING N.E. 131ST STREET FROM WEST DIXIE HIGHWAY, WEST TO N.E. 6TH AVENUE IN THE CITY TO BE KNOWN AS “BILL AND PENNY VALENTINE STREET”; ACKNOWLEDGEMENT OF DONATION OF DAVID LEVEN; PROVIDING FOR AN EFFECTIVE DATE AND FOR ALL OTHER PURPOSES.

WHEREAS, Bill Valentine was an active resident in the City of North Miami for over fifty (50) years; and

WHEREAS, Bill Valentine was a former City Councilman and Mayor of the City of North Miami; and

WHEREAS, at the time of his death, Bill Valentine was an active member of the North Miami Chamber of Commerce; and

WHEREAS, Penny Valentine, his wife, continues to be actively involved in the North Miami Chamber of Commerce and the City of North Miami; and

WHEREAS, in recognition of their dedication and commitment to the City of North Miami, the Mayor and City Council wish to designate N.E. 131st Street from West Dixie Highway, west to N.E. 6th Avenue to be known as “Bill and Penny Valentine Street.”

WHEREAS, a resident of the City of North Miami, David Leven, has volunteered to underwrite the costs of any and all signs to indicate the designation of said street as “Bill and Penny Valentine Street.”

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. Approval of Street Designation. The Mayor and City Council of the City of North Miami, Florida hereby designate N.E. 131st Street from West Dixie Highway, west to N.E. 6th Avenue to be known as “Bill and Penny Valentine Street.”

Section 2. Acknowledgement of Donation of David Leven. The Mayor and City Council hereby acknowledge the generous donation of City of North Miami resident, David Leven, to underwrite the costs of signage for said designation of "Bill and Penny Valentine Street."


Section 3. Authorization of City Manager. The City Manager is hereby authorized to do all things necessary to effectuate this Resolution.

Section 4. Effective Date. This Resolution shall be effective immediately upon adoption.


