

RESOLUTION NO. R-2008-75

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, RENAMING THE ROTARY OVERBROOK SHORES TOT LOT ON NORTHWEST 2ND AVENUE AND 123RD STREET AS THE “ROTARY OVERBROOK SHORES TOT LOT AT ALHAMBRA HEIGHTS”; PROVIDING FOR AN EFFECTIVE DATE AND FOR ALL OTHER PURPOSES.

WHEREAS, Alhambra Heights is an organized neighborhood east of North Miami Avenue and west of Northwest 7th Avenue in the City of North Miami; and

WHEREAS, the Rotary Overbrook Shores Tot Lot is a parks facility in the Alhambra Heights neighborhood; and

WHEREAS, parks facilities in similarly situated neighborhoods are so named to identify with the neighborhood; and

WHEREAS, residents of Alhambra Heights feel that renaming the Tot Lot would allow the neighborhood to be recognized while still holding on to the historical name the park currently holds; and

WHEREAS, the City of North Miami, the Mayor and City Council wish to rename the Rotary Overbrook Shores Tot Lot on Northwest 2nd Avenue and 123rd Street as the “Rotary Overbrook Shores Tot Lot at Alhambra Heights.”


NOW THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. Renaming of Tot Lot. The Mayor and City Council of the City of North Miami, Florida hereby rename the Rotary Overbrook Shores Tot Lot on Northwest 2nd Avenue and 123rd Street as the “Rotary Overbrook Shores Tot Lot at Alhambra Heights.”


Section 2. Authorization of City Manager. The City Manager is hereby authorized to do all things necessary to effectuate this Resolution.

PASSED AND ADOPTED by a 5-0 vote of the Mayor and City Council of the City of North Miami, Florida, this 24 day of June, 2008.


