

RESOLUTION NO. 2020-R-20

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, APPROVING THE CITY ADMINISTRATION'S COMPETITIVE SELECTION OF CARLOS RIVERO PLUMBING & SEPTIC TANK CONTRACTOR, INC., AS THE LOWEST RESPONSIVE-RESPONSIBLE CONTRACTOR TO FURNISH LABOR, EQUIPMENT, MATERIALS, AND EXPERTISE REQUIRED TO PROVIDE STORMWATER AND SANITARY SEWER MAINTENANCE SERVICES; FURTHER AUTHORIZING THE CITY MANAGER AND CITY ATTORNEY TO NEGOTIATE AND EXECUTE AN AGREEMENT WITH THE SELECTED CONTRACTOR, FOR THE PROVISION OF SERVICES IN AN AMOUNT NOT TO EXCEED ONE HUNDRED FIFTY THOUSAND DOLLARS (\$150,000.00) ANNUALLY, IN ACCORDANCE WITH THE TERMS, CONDITIONS AND SPECIFICATIONS CONTAINED IN INVITATION FOR BIDS (IFB) NO. 05-19-20 ; PROVIDING FOR AN EFFECTIVE DATE AND FOR ALL OTHER PURPOSES.**

**WHEREAS**, on October 4, 2019, the City of North Miami ("City") advertised *Invitation for Bids No. 05-19-20 Maintenance of Stormwater & Sanitary Sewer Structures* ("IFB"), requesting bids from qualified and experienced Contractors to provide services for vacuum cleaning/jetting and inspection of, and emergency response to, city owned stormwater, sanitary sewer structures and appurtenances including but not limited to: catch basins, inlets, manholes, pipe outfall, pollution control devices, sanitary sewer pipes and lift stations, in accordance with the specifications and conditions contained within the IFB (collectively referred hereto as "Services"); and

**WHEREAS**, in response to the IFB, Carlos Rivero Plumbing & Septic Tank Contractor, Inc. ("Contractor") submitted its bid and was competitively selected by City administration as the lowest responsive-responsible bidder, with qualifications and references demonstrating to be the most advantageous to the City in the provision of Services; and

**WHEREAS**, the Contractor has manifested the capability and willingness of providing Services to the City for an initial three (3) year term with two (2) additional one-year options to renew periods, at a cost not to exceed One Hundred Fifty Thousand Dollars (\$150,000.00) annually, in accordance with the terms, conditions and specifications contained in the IFB; and

**WHEREAS**, City administration respectfully requests that the Mayor and City Council approve the selection of Contractor and further authorize an agreement for the completion of Services; and

**WHEREAS**, the Mayor and City Council find the selection of Contractor to be in the best interest of the City, and that the provision of Services are designed to protect the public health, safety, and welfare.

**NOW THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:**

**Section 1.**      **Selection Approval.** The Mayor and City Council of the City of North Miami, Florida, hereby approve the City Administration's competitive selection of Carlos Rivero Plumbing & Septic Tank Contractor, Inc., as the lowest responsive-responsible contractor to provide sanitary sewer maintenance services.

**Section 2.**      **Authority of City Manager and City Attorney.** The Mayor and City Council of the City of North Miami, Florida, hereby authorize the City Manager and City Attorney to negotiate and execute an agreement for the stated services, in the amount of One Hundred Fifty Dollars (\$150,000.00) for an initial term of three (3) years with two (2) additional one-year options to renew, in accordance with the terms, conditions and specifications contained in *Invitation for Bids No. 05-19-20 Maintenance of Stormwater & Sanitary Sewer Structures.*

**Section 3.**      **Effective Date.** This Resolution shall become effective immediately upon adoption.
