

RESOLUTION NO. 2020-R-21

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA AUTHORIZING THE SUBMITTAL OF A GRANT APPLICATION AND AUTHORIZING THE INTERIM CITY MANAGER AND CITY ATTORNEY TO NEGOTIATE AND EXECUTE AN AGREEMENT BETWEEN THE CITY OF NORTH MIAMI AND MIAMI-DADE COUNTY FOR GRANT FUNDS FROM THE NEAT STREETS GRANT PROGRAM; PROVIDING AN EFFECTIVE DATE AND FOR ALL OTHER PURPOSES.

WHEREAS, the City is desirous of applying for a Neat Streets Grant from Miami-Dade County; and

WHEREAS, the City of North Miami is requesting a grant in the amount of twenty five thousand dollars (\$25,000.00) with a twenty five thousand dollars (\$25,000.00) match for a total project cost in the amount of fifty thousand dollars (\$50,000.00); and

WHEREAS, the funds will be used to plant one hundred forty (140) native or Florida-friendly trees on North Miami's corridors and gateways between Northeast 127th Street to 134th Street and Northeast 10th Avenue to Northeast 14th Avenue; and

WHEREAS, the objective is to increase tree canopy coverage, promote environmental awareness in our community, and improve aesthetics, quality of life and property values; and

WHEREAS, the Mayor and City Council wish to authorize the submittal of a grant application as well as to fully authorize the negotiation and execution of an agreement for grant funds between the City and Miami-Dade County.


NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. Authorization for Submittal of Application. The Mayor and City Council hereby authorize the submittal of the City of North Miami's application for a Neat Streets grant from Miami-Dade County.

Section 2. Authority to Interim City Manager and City Attorney. The Interim City Manager and City Attorney are hereby authorized to negotiate and execute an agreement between the City of North Miami, Florida and Miami-Dade County.

Section 3. Effective Date. This Resolution shall become effective immediately upon adoption.
