

RESOLUTION NO. 2020-R-53

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AUTHORIZING THE INTERIM CITY MANAGER AND CITY ATTORNEY TO EXECUTE AN INTERLOCAL AGREEMENT BETWEEN THE CITY OF NORTH MIAMI AND MIAMI-DADE COUNTY FOR THE ANNEXATION OF LAND IDENTIFIED AS THE “GRATIGNY DIXIE ANNEXATION AREA” BY THE CITY OF NORTH MIAMI; FURTHER AUTHORIZING THE INTERIM CITY MANAGER TO TAKE ALL STEPS NECESSARY AND APPROPRIATE TO IMPLEMENT THE TERMS AND CONDITIONS OF THE AGREEMENT; PROVIDING FOR AN EFFECTIVE DATE AND FOR ALL OTHER PURPOSES.

WHEREAS, the City of North Miami and Miami-Dade County wish to make the most efficient use of their powers by entering into an Interlocal Agreement, pursuant to section 163.01, Florida Statutes; and

WHEREAS, section 6.04 of the Home Rule Charter for Miami-Dade County authorizes the County to approve changes to municipal boundaries; and

WHEREAS, the City of North Miami desires to changes its boundary by annexing the tract of land described as “Gratigny Dixie Annexation Area,” as specified in the attached Exhibit “A”;

WHEREAS, the Mayor and City Council of the City of North Miami desire to enter into this Interlocal Agreement setting forth the points of compromise between the City of North Miami and Miami-Dade County with respect to the annexation of this tract of land; and

WHEREAS, the City desires to provide residential solid waste collection, and as such will enter into a separate Interlocal Agreement with Miami Dade County conveying collection authority to the City and expanding and extending the existing Interlocal Agreement with the County for disposal services.

NOW THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. Authority of Interim City Manager and City Attorney. The Interim City Manager and City Attorney are authorized and directed to negotiate, execute and deliver an Interlocal Agreement between the City of North Miami and Miami-Dade County in the substantial format attached and identified hereto as "Exhibit A".

Section 2. Authorization of Interim City Manager. The Interim City Manager is hereby authorized to do and cause to be done any and all acts and things necessary or proper for carrying out the transactions contemplated by this Resolution.

Section 3. Effective Date. This Resolution shall be effective immediately upon adoption.
