

RESOLUTION NO. 2020-R-63

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, RATIFYING THE SUBMITTAL OF A GRANT APPLICATION AND AUTHORIZING THE INTERIM CITY MANAGER AND CITY ATTORNEY TO NEGOTIATE AND EXECUTE AN AGREEMENT BETWEEN THE CITY OF NORTH MIAMI AND THE UNITED STATES DEPARTMENT OF JUSTICE FOR GRANT FUNDS FROM THE BJA FY20 CORONAVIRUS EMERGENCY SUPPLEMENTAL FUNDING PROGRAM; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.**

**WHEREAS**, the Mayor and City Council are desirous of securing a grant from the BJA FY20 Coronavirus Emergency Supplemental Funding Grant Program; and

**WHEREAS**, the City of North Miami was approved for a grant at a total cost of One Hundred Ten Thousand Seventy-Two Dollars (\$110,072.00) in grant funds with no required match; and

**WHEREAS**, funds will be used toward the North Miami Police Department's Coronavirus Response; and

**WHEREAS**, the Mayor and City Council wish to ratify the submittal of a grant application as well as to fully authorize the negotiation and execution of an agreement between the City and the United States Department of Justice for the purpose of securing grant funds.

**NOW THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:**

**Section 1. Ratification of Submittal of Grant Application.** The Mayor and City Council of the City of North Miami, Florida, hereby ratify the submission of an application to the United States Department of Justice for a BJA FY20 Coronavirus Emergency Supplemental Funding Program Grant.

**Section 2. Authority to Interim City Manager and City Attorney.** The Interim City Manager and City Attorney are hereby authorized to negotiate and execute an agreement between the City of North Miami, Florida and the United States Department of Justice.

**Section 3. Effective Date.** This Resolution shall become effective immediately upon adoption.
