

RESOLUTION NO. 2020-R-64

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, RATIFYING THE SUBMITTAL OF A GRANT APPLICATION AND AUTHORIZING THE INTERIM CITY MANAGER AND CITY ATTORNEY TO NEGOTIATE AND EXECUTE AN AGREEMENT BETWEEN THE CITY OF NORTH MIAMI AND THE UNITED STATES TENNIS ASSOCIATION (USTA) FOR GRANT FUNDS FROM THE FACILITY RECOVERY GRANT PROGRAM; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.

WHEREAS, the Mayor and City Council are desirous of securing a grant from the United States Tennis Association (“USTA”) Facility Recovery Grant Program; and

WHEREAS, the City of North Miami was approved for a grant at a total cost of Five Thousand Dollars (\$5,000.00) in grant funds with no required match; and

WHEREAS, funds will be used to defray some of the tennis related expenses associated with the opening of the City’s facilities such as the purchase of tennis balls and teaching equipment, cleaning and sanitizing efforts, and installation of no-touch technologies; and

WHEREAS, the Mayor and City Council wish to ratify the submittal of a grant application as well as to fully authorize the negotiation and execution of an agreement between the City and the USTA for the purpose of securing grant funds.

NOW THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. Ratification of Submittal of Grant Application. The Mayor and City Council of the City of North Miami, Florida, hereby ratify the submission of an application to the United States Tennis Association for a Facility Recovery Program Grant.

Section 2. Authority to Interim City Manager and City Attorney. The Interim City Manager and City Attorney are hereby authorized to negotiate and execute an agreement between the City of North Miami, Florida and the United States Tennis Association.

Section 3. Effective Date. This Resolution shall become effective immediately upon adoption.
