

RESOLUTION NO. 2020-R-76

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, APPROVING THE MENTAL HEALTH ASSISTANCE PROGRAM GUIDELINES, AS SPECIFIED IN EXHIBIT “A”; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.

WHEREAS, the City of North Miami (“City”) was awarded Four Hundred Fifty-Two Thousand Six Hundred Ninety-Two Dollars (\$452,692.00) in supplemental Community Development Block Grant (“CDBG-CV) funds under the Coronavirus Aid, Relief and Economic Security (“CARES”) Act signed by the President of the United States on March 27, 2020; and

WHEREAS, on May 26,2020, the Mayor and City Council approved Resolution No. 2020-R- 57 adopting the First Amendment to the FY 2019-2020 Action Plan and allocating a portion of the CDBG-CV funding to the Mental Health Assistance program; and

WHEREAS, the City is required by program regulations to develop specific policies and procedures for program activities funded under CDBG programs; and

WHEREAS, with the emergence of the COVID-19 health crisis, more and more residents are becoming mentally affected by the pandemic, and as a responsible local government the City has decided to address the issue by using a portion of the supplemental allocation to fund this activity; and

WHEREAS, the City has established guidelines for the implementation of the Mental Health Assistance Program attached hereto as Exhibit “A”; and

WHEREAS, the Mayor and City Council desire to implement the Mental Health Assistance Program to assist low to moderate-income households affected by the health crisis created by the pandemic.


