

RESOLUTION NO. 2020-R-78

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, APPROVING THE EVALUATION COMMITTEE'S RESULTS AND THE SELECTION OF WASTE PRO OF FLORIDA, INC. TO PROVIDE SANITATION SERVICES; FURTHER AUTHORIZING THE CITY MANAGER AND CITY ATTORNEY TO NEGOTIATE AND EXECUTE AN AGREEMENT IN AN AMOUNT NOT TO EXCEED THREE MILLION THREE HUNDRED THIRTY-EIGHT THOUSAND SIX HUNDRED FIFTY-EIGHT DOLLARS (\$3,338,658.00) ANNUALLY, IN ACCORDANCE WITH THE TERMS, CONDITIONS AND SPECIFICATIONS CONTAINED IN REQUEST FOR PROPOSALS NO. 22-18-19; PROVIDING FOR AN EFFECTIVE DATE AND FOR ALL OTHER PURPOSES.

WHEREAS, on May 6, 2019, the City of North Miami ("City") issued *Request for Proposals No. 22-18-19 – Sanitation Services* ("RFP"), seeking proposals from qualified and experienced firms to provide citywide sanitation services to the City's residential and commercial establishments within the City, in accordance with the terms, conditions and specifications contained in the RFP ("Services"); and

WHEREAS, in response to the RFP, the City received two (2) proposals, and two (2) no bid responses; and

WHEREAS, Waste Pro of Florida, Inc. ("Contractor"), was determined to be the highest ranked responsive and responsible bidder possessing the qualifications and references demonstrating to be the most advantageous to the City in the provision of Services; and

WHEREAS, the Contractor has manifested the capability and willingness of providing Services to the City for an initial seven (7) year term, with the City's option to renew for three (3) additional one (1) year periods, at a cost not to exceed Three Million Three Hundred Thirty-Eight Thousand Six Hundred Fifty-Eight Dollars (\$3,338,658.00) annually, pursuant to the terms, conditions, requirements and specifications contained in the RFP; and

WHEREAS, City administration respectfully requests that the Mayor and City Council approve the selection of Contractor and further authorize the negotiation and execution of an agreement for the provision of Services.

NOW THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. **Selection Approval.** The Mayor and City Council of the City of North Miami, Florida, hereby approve the City Administration's recommendation of Waste Pro of Florida, Inc., to provide the City with sanitation services.

Section 2. **Authority of City Manager and City Attorney.** The Mayor and City Council of the City of North Miami, Florida, hereby authorize the City Manager and City Attorney to negotiate and execute an agreement in an amount not to exceed Three Million Three Hundred Thirty-Eight Thousand Six Hundred Fifty-Eight Dollars (\$3,338,658.00) annually, in accordance with the terms, conditions and specifications contained in *Request for Proposals No. 22-18-19 – Sanitation Services.*

Section 3. **Effective Date.** This Resolution shall be effective immediately upon adoption.
