A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, DECLARING NO OBJECTION AND SUPPORTING THE DESIGNATION OF WEST DIXIE HIGHWAY/S.R. 909 FROM BISCAYNE CANAL TO N.E. 143 STREET AS "HARRIET TUBMAN HIGHWAY"; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.

WHEREAS, Florida Statute 334.071 entitled "Legislative Designation of Transportation Facilities" states that erection of markers shall be contingent upon the appropriate city or county commissioner, passing a resolution in support of the particular honorary designation; and

WHEREAS, pursuant to the request made by the Florida Department of Transportation ("FDOT") for honorary designation of roads located in the City of North Miami ("City"), the North Miami City Council has no objections and supports the renaming of portions of West Dixie Highway running through the City of North Miami; and

WHEREAS, the Mayor and City Council support the designation of state transportation facilities ("roadways") that are located within the City as follows:

The portion of West Dixie Highway/S.R. 909, between Biscayne Canal and N.E. 143 Street is designated as "Harriet Tubman Highway."

NOW THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

- Section 1. Approval of Street Designation. The Mayor and City Council declare no objection and supports the designation of West Dixie Highway/S.R. 909, between Biscayne Canal and N.E. 143 Street as "Harriet Tubman Highway."
