

RESOLUTION NO. 2020-R-117

RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AUTHORIZING THE CITY MANAGER TO EXECUTE AN INTERLOCAL AGREEMENT FOR FEDERALLY-FUNDED SUBAWARD, IN SUBSTANTIALLY THE ATTACHED FORM, BETWEEN THE CITY OF NORTH MIAMI AND MIAMI-DADE COUNTY FOR THE REIMBURSEMENT OF ELIGIBLE EXPENSES FROM CORONAVIRUS AID, RELIEF, AND ECONOMIC SECURITY ACT (“CARES ACT”) FUNDS; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.

WHEREAS, the Coronavirus Aid, Relief, and Economic Security (“CARES”) Act was signed into law on March 27, 2020 and appropriated \$150 billion of direct federal funding for state and local governments to address unforeseen financial needs and risks created by the Novel Coronavirus (“COVID-19”) pandemic public health emergency; and

WHEREAS, states and units of local government with more than 500,000 residents received direct federal funding through the Coronavirus Relief Fund; and

WHEREAS, on August 4, 2020, the Miami-Dade County Board of County Commissioners (“County”) approved a motion that authorized the County Mayor to execute federally funded sub-award agreements with Miami-Dade County municipalities; and

WHEREAS, the County has allocated One Hundred Thousand Dollars (\$100,000.00) in CARES Act funding to be distributed as follows: Seventy-Five Thousand Dollars (\$75,000.00) for reimbursement of FEMA local match expenditures and any CARES Act eligible governmental operation expenditures that are not FEMA reimbursable and Twenty-Five Thousand Dollars (\$25,000.00) for municipal programmatic proposals subject to advance approval; and

WHEREAS, the City of North Miami (“City”) has taken unprecedented steps in response to the impact of the COVID-19 pandemic on our community and has experienced unforeseen financial needs and risks created by the COVID-19 pandemic public health emergency; and

WHEREAS, the Mayor and City Council desire to approve the Interlocal Agreement for Federally-Funded Subaward to receive reimbursement of eligible CARES Act expenditures, in substantially the form attached as Exhibit "A."

NOW THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. **Authority of City Manager.** The City Manager is authorized to execute an Interlocal Agreement for Federally-Funded Subaward, in substantially the attached form, between the City of North Miami and Miami-Dade County for the reimbursement of eligible expenses from CARES Act Funds.

Section 2. **Effective Date.** This Resolution shall be effective immediately upon approval.
