

RESOLUTION NO. 2020-R-119

RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, RATIFYING THE EXECUTION OF A FIRST AMENDMENT TO THE CORONAVIRUS RELIEF FUND (CRF) SUBRECIPIENT AGREEMENT BETWEEN THE CITY OF NORTH MIAMI AND FLORIDA HOUSING FINANCE CORPORATION FOR THE FUNDING OF THE EMERGENCY MORTGAGE ASSISTANCE PROGRAM (“EMAP”); PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.

WHEREAS, the City of North Miami (“City”) and Florida Housing Finance Corporation (“Florida Housing”) entered into a Coronavirus Relief Fund Subrecipient Agreement (“Agreement Number 130-2020”) dated July 29, 2020; and

WHEREAS, on September 8, 2020 the Mayor and City Council approved the Execution of a Coronavirus Subrecipient Agreement for the implementation of the Emergency Mortgage Assistance Program (“EMAP”), as authorized by Resolution No. 2020-R-98; and

WHEREAS, on October 1, 2020, the City and Florida Housing entered into a First Amendment to Agreement Number 130-2020 to provide for a second disbursement of funds; and

WHEREAS, Agreement Number 130-2020 has been updated to include a definition for Technical Bulletin and to provide for a second distribution of funds in the amount of One Hundred Three Thousand Five Hundred Dollars (\$103,500.00) for a total distribution amount of Two Hundred Seventy-Six Thousand Dollars (\$276,000.00) under the terms of the contract; and

WHEREAS, as a subrecipient, the City of North Miami will continue to follow guidelines and technical assistance in accordance with Florida Housing requirements; and

WHEREAS, the Mayor and City Council believe that entering into an amendment for this purpose will benefit the residents of the City and desire to ratify the execution of the First Amendment to Contract 130-2020, in substantially the attached form.

NOW THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. Ratification. The Mayor and City Council of the City of North Miami, Florida, hereby ratify the First Amendment to Agreement Number 130-2020 between the City of North Miami and the Florida Housing Finance Corporation, attached as Exhibit "A".

Section 2. Effective Date. This Resolution shall become effective immediately upon approval.
