

RESOLUTION NO. 2020-R-125

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, RATIFYING THE “DECLARATION OF A STATE OF EMERGENCY” IMPOSED BY THE CITY MANAGER ON NOVEMBER 8, 2020 AND THE “TERMINATION OF A STATE OF EMERGENCY” ISSUED DUE TO TROPICAL STORM ETA; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.

WHEREAS, the City of North Miami (“City”) faced dangerous conditions of sufficient severity and magnitude to warrant coordinated local government action to prevent or alleviate the damage, loss, hardship or suffering threatened or caused thereby; and

WHEREAS, County Manager Carlos A. Gimenez declared a State of Emergency for Miami-Dade County due to the threat of impending Tropical Storm Eta; and

WHEREAS, Governor Ron DeSantis declared a State of Emergency for portions of Florida due to the threat of impending Tropical Storm Eta; and

WHEREAS, Tropical Storm Eta caused a condition of peril of life and property necessitating the proclamation of the existence of an emergency and in accordance with section 2-419 of the North Miami Code of Ordinances, the City Manager declared a state of emergency due to hurricane; and

WHEREAS, the emergency dangers and threats of Tropical Storm Eta have passed, and the City Manager has terminated the State of Emergency.

NOW THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. Ratification of Declaration of State of Emergency. The Mayor and City Council of the City of North Miami, Florida, hereby ratify the “Declaration of State of Emergency” imposed by the City Manager on November 8, 2020, attached as Exhibit “A.”

Section 2. Ratification of Termination of State of Emergency. The Mayor and City Council of the City of North Miami, Florida, hereby ratify the “Termination of State of Emergency”, attached as Exhibit “B.”

Section 3. Authority of City Manager. The City Manager is hereby authorized to do all things necessary to effectuate the terms of this resolution.

Section 4. Effective Date. This Resolution shall become effective immediately upon adoption.
